Sub: - Harassment on NUBSNLW (FNTO) Asstt. District Secretary & office bearers in U.P. (East) Circle, request to necessary instructions to the U.P. (East) Circle for cancellation of Irregular Transfers-reg.

Ref: - My letter No NU/CHQ/15/UP (E) dated 31-01-2017.

With refer to the above said letter the undersigned is constrained to bring your kind notice the field officers Lucknow SSA are harassing our union members by issuing irregular Transfers to the officials who are my Asstt. District Secretaries & office bearers with a malafied intention to satisfy the interest of Recognized Unions.

For example

The following officials were issued Transfer orders Shri B. K. Yadav, Asstt. Dist. Secy Lucknow, Shri S. K. Srivastava, Dist. Vice President Lucknow, Shri Naresh Bhardwaj, District Org. Secy. Shri S. N. Bhagat and Shri Sri Kishan.

Recently Shri B. K. Yadav Asstt. District Secretary Lucknow is Transferred Rajaji Puram to Bala Ganj. The same official Shri B. K. Yadav, Asstt. Dist. Secy was transferred just before 6 months and kept pending as per our union request. Now again he was issued irregular Transfer order to Rajaji Puram with a malafied intention to satisfy the NFTE BSNL union, it is only the clear proof that in the NFTE BSNL Banner. The DE/SD Lucknow name Shri K. K. Ojha, DE Phones, Shri S. N. Singh SDE Rajaji Puram are printed (a copy of the poster attached for your ready reference). Our Union demands to Transfer these two officers from the Lucknow otherwise they may spoil the Image of BSNL.

Circle Secretary & District Secretary U.P. (East) is approached to the PGM Lucknow and DGM Lucknow they are convinced and accepting their weakness that they are in the clutches of NFTE BSNL.

I therefore, request you Madam kindly look into the matter personally and necessary guidelines may be issued to CGM U.P. (East) Lucknow & PGM Lucknow to cancel the above said irregular Transfers. The PGM may be advised be impartial/Transparent while issuing the Transfer Orders as per BSNL Transfer Policy.
