£2	3	Whether an employee once reviewed, shall be reviewed again ?	Once a decision has been taken by the appropriate authority to retain an employee beyond the specified age, under the BSNL CDA Rule 55(ii)(b) he would ordinarily continue in service till he attains the age of retirement. If, however, the appropriate authority later considers after the review that the retention of the employee will not be in the Company's interest, that it may take necessary action to retire the employee by following the due procedure.
	4	About three months notice: before an employee attains the specified age.	Once a decision is taken to prematurely retire an employee, the retirement should take place after the employee attains the specified age and a notice even longer than three months may become necessary if notice is issued more than 3 months in advance. He shall retire from service on the forenoon of(the date following the date on which he attains the specified age) or the forenoon of the day following the date of expiry of three months computed from the date following the date of service of this notice on him, whichever is later.
	5	About three months notice: if an employee has already attained the specified age	shall retire from service on the forenoon of the day following the date of expiry of three months computed from the date following the date of service of this notice on him.
