Sub: - Review of result of failed SC/ST candidates in LICEs regarding...

Ref: - Letter No. 9-2/2016-Rectt dated 28.08.2017 & No. 52-1/2016-Rectt dated 17.10.2017.

In reference to aforesaid context, it is intimated that result of failed SC/ST candidates of LICEs held in 2016 in the cadre of JAO 40% & 10% and JTOs (VY: - 2013-14, 2014-15, 2015-16) were reviewed in the light of above referred letters which were meant for above LICEs only as per approval given by the Competent Authority. However, while communicating the approval to all Circles; inadvertently, it has been made a generalised letter meaning thereby that it is applicable to all LICEs which are to be conducted in future.

2. In this regard, it is intimated that in-principle, all the LICEs are unique and thus premise to review result of failed SC/ST candidates, in each LICE, differs. Therefore, relaxation, if any, thereby to failed SC/ST candidates has to be decided/reviewed on each occasion (LICE). The process of review of results of failed SC & ST candidates in a particular LICE has to be initiated by Recruitment Branch BSNL CO/Circle, as the case may be, after the publication of result in accordance with the direction of Competent Authority by forming a committee, consisting of members from **Cadre Controlling Authority, Recruitment Section & SCT Section** invariably as per usual practice. The Committee shall take into account DoT Letter No. 22-5/91-NCG dated 30.11.92, DoP&T's "BROCHURE on Reservation For SC, ST & Other Backward Classes In Services" circulated vide Letter No. "DPE-GM-15/0001/2016-GM-FTS-5921 dated 17.10.2016" and any other relevant orders related to "Review of result of failed SC/ST candidates in LICEs" prevailing at that time.

3. In view of the above, letter No. 9-2/2016-Rectt dated 28.08.2017 & No. 52-1/2016-Rectt dated 17.10.2017 issued by Recruitment Branch BSNL CO for review of result of failed SC & ST candidates are applicable for candidates of LICEs held in 2016 in the cadre of JAO 40% & 10% and JTOs (VY: - 2013-14, 2014-15, 2015-16) only.

4. Cut-off date "02.12.2014" as mentioned in previous letters No. 52-1/2016-Rectt dated 06.10.2017 and 17.10.2017 shall remain unchanged; i.e. "Results of failed SC/ST candidates in LICEs to be reviewed only for LICEs/LDCEs notified on or after 02.12.2014".

5. However, there will be no change in the status of already reviewed cases prior to issue of this letter.
