On the basis of their performance in the Limited Internal Competitive Examination (LICE) for promotion from Group 'C' to the grade of JAO under 40% quota held on 05/03/2017 for left out Candidates of J & K, the merit list of candidates, who secured minimum qualifying marks, has been prepared on the basis of SoP of online examination, after evaluating queries received, if any, from candidates.

2. On the basis of SoP/submissions received through mail, Unions, Associations, in persons etc., if any, in the context of wrong answers keys/questions, an Expert Committee was constituted to look in to the said submissions and accordingly recommended to modify few of the answer key options (Copy of Modified Answer Key is Annexed as Annexure herewith) and accordingly the on the basis of modified answer key, the merit list of the qualified candidates have been prepared (Annexure-B attached herewith).
3. A number of candidates had or might have approached various CAT Benches/Courts across the country for the eligibility or otherwise for appearing in the aforesaid LICE and as per the Interim Orders given by the Courts, if any, some candidates might have been provisionally allowed to appear in the said LICE. As such, promotion to such candidates, if any, may be incorporated only after the final outcome of the respective Hon'ble Courts.
4. The aforesaid list has been prepared considering only the Parent Circle of the candidate as per online registration of candidature. In case of any inter-Circle/Rule-8 transfer cases etc., such candidates may approach to the respective Circle under intimation to Cadre Controlling Authority for revision of posting on promotion as per usual practice.
5. The concerned Circles must verify the eligibility of all the candidates in respect of the candidature before sending for training and/or promoting them to the grade of JAO as per merit list vide Annexure, subject to the availability of circle/category-wise vacancy in respective circles.
6. Since, no clarity in "seniority" is seen in RR of JAO, it is, therefore, proposed to declare a modified Circle-wise Merit as placed herewith. The names of candidates, their Roll Nos., HRMS Nos. and Category have been shown as furnished by the Candidates concerned during Online Registration process/Online examination. All out efforts have been made to prepare the aforesaid list error free. However, any discrepancy/error noticed in any of the column may please be brought to the notice of this Office immediately latest by 31/04/2017 positively by e-mail : itgmrectt@gmail.com. No request shall be entertained under any circumstances, if the same is received after 31/04/2017.
