## Central Working Committee Meeting at Patna

The Central Working Committee of NUBSNLW (FNTO) has been held on 7<sup>th</sup> & 8<sup>th</sup> July-2017 at Telegraph Recreation Club Patna Bihar under the president-ship of Shri Thomas John K. President FNTO. Shri R. P. Sinha Circle Secretary. Bihar Circle welcomed the CWC Members. The Circle Union has arranged an Open session of mass gathering which was addressed by senior officers of BSNL, INTUC State President, Leaders of sister Unions, over and above the leaders of FNTO.

Accordingly to the agenda notified the following items were discussed and decisions were taken as follows.

The CWC decided to maintain functional unity with other Unions and support programmes on issue basis in the interest of the BSNL workers. The CWC decided to participate in the Agitational programme of Hunger strike on 13-07-2017 notified by the BSNLEU Union & Associations. However it is also decided to participate in the one day strike of 27-07-2017. The CWC urged to both the recognized unions to conduct the **united Agitational Programmes** on common issues, such as 3<sup>rd</sup> Wage Revision, Bonus, Compassionate Ground appointments, change of Designation etc, to build up pressure on BSNL Management to settle the demands without any delay.

The CWC decided not to have any alliance with any of the Recognized Unions nor accept Council seats at any level, for the time being. In this regard a resolution moved by Shri D. Chandrasekaran JGS & C/S Tamil Nadu Circle and Shri Alok Nandi Dy. GS & C/S Calcutta Telephones was adopted. However the CHQ is authorized to take decision on common issues Agitational Programmes.

The CWC felt that though the Cochin High Court Case on membership verification is dismissed, the BSNL should not accept the other minor union members in the councils unless BSNL rules are amended.

The CWC decided to continue in the Forum i.e. Organization of BSNL Unions & Associations lead by FNTO. The CWC directed to conduct Circle Conferences wherever due before 31-12-2017. The CWC reviewed quota position and learned that some of the Circles are receiving the CHQ quota from the Circle Office, but not remitting to the CHQ. This is gross indiscipline and the CHQ will have no other alternative but compliant against such unauthorised actions.

The invitation of Kolkata Telephones District to hold next All India Conference at Kolkata is accepted. The AIC have to be conducted by Feb-2018/ March-2018.
