The regulation from IRDA do not allow enrolling new members in the existing scheme. Only BSNL employees who have joined upto 31.7.2014 are covered under the existing policy. LIC has proposed New Group Insurance (GI) Policy for the BSNL employees who have joined the company after 31.7.2014.
